Together, we aim to ensure that every magistrate and judge in Tanzania has seamless access to crucial legal information, regardless of their location.

The significance of Pocket Law lies in its potential to expedite court cases, enhance the quality of justice and legal work, and facilitate the rule of law, particularly in areas with limited internet connectivity. It empowers the legal sector broadly with a practical tool to serve the public more efficiently.

Pocket Law is launched and rolled out in partnership with the Judiciary today. However, Pocket Law is freely available to everyone - government and private lawyers, paralegals, legal advice clinics, mediation centers, students, and the mwananchi.

Pocket Law is a fully searchable off-line version of the much beloved TanzLII service, which publishes caselaw from all superior courts in Tanzania, and soon, in partnership with the Office of the Attorney General, will host a complete set of legislation. As such, Pocket Law is updated as soon as TanzLII is updated. As such, Pocket Law will not be unfamiliar to you - it looks and feels exactly like TanzLII.

This launch aligns with the Tanzanian justice sector's commitment to making the law more accessible during Law Week 2024. Pocket Law is a vital component of this effort, offering a digital solution that simplifies access to legal resources for all Tanzanians.

I want to acknowledge the visionary leadership of our partners, the Tanzanian Judiciary, in recognizing the value of this innovation. Their partnership is instrumental in driving this initiative forward. In future, we hope to develop partnerships in other areas of the justice sector, and disseminate this essential legal research tool to everyone who assists the citizens of Tanzania with their legal issues.
