The petitioner, **MARWA NAIRUSYA GORDON** (a widower) has filed a petition for grant of letters of administration of his late wife, **ANGELINA HENRY MUHAMA** (deceased). According to the petition duly filed on 06<sup>th</sup> December 2019 and its annexures (death certificate and clan meeting) the deceased passed away on **29<sup>th</sup> April 2018** intestate at Mount Meru Hospital at Arusha.

On hearing of this matter the petitioner was represented by the learned advocate **Mr. Zuberi Ngawa** who stated that they have been able to make a requisite citation through a Government Gazette dated 31<sup>st</sup>

January 2020 and Habari Leo Newspapers of 14-20<sup>th</sup> January 2020. And no caveat that has been entered to the date of hearing of this petition, it is therefore their prayer that the petition be granted.

Both Petitioner and deceased were blessed with two issues, namely; **CARREN MARWA GORDON** and **COLLINS MARWA GORDON** and the petition is to the effect that the assets subjects of the intended administration are as follows;


- a) Pension Contribution
- b) 20% shares in a Company known as "**M**" and "**A**" Engineering Ltd.
- c) 50% shares in Tipper Isuzu T 123 ALA, Tipper Canter T 816 DHY, Pickup Hilux T 124 ABJ and Prado T 476 DMJ

The petitioner being the widower, responsible in caring of the children left by the deceased named above and above all, he has been chosen by the clan members, there is no apparent reason to be denied of a right of being granted letters of administration of estate of his late wife unless the contrary would be established, In our petition, the petitioner is a beneficiary to the estate of the deceased person and father of the deceased's children.


That told, the petitioner is hereby granted letters of administration of the estate of his late wife, **ANGELINA HENRY MUHAMA.**

Having been appointed administrator, the petitioner is now ordered to accordingly administer the deceased's estate and he is further directed to make and exhibit inventory of the deceased's estate in this court **within six (6)** months from the date of this ruling and present final accounts within one year or within such further time as may be extended by the court from time to time.
