**RULING**

**L. M. MLACHA, J.**

The petitioners BOB RICHARD NDASSA, ROBERT RICHARD NDASSA and GODREY NDALAHWA filed the present petition seeking to be appointed joint administrators of the estate of the late RICHARD MGANGA NDASSA who died intestate at Dodoma general hospital on 29/04/2020. The petition showed that the deceased left the following children: -

2. Alex Richard Ndassa
3. Upendo Richard Ndassa
4. Robert Richard Ndassa
5. Betty Richard Ndassa
6. Bob Richard Ndassa
7. Annie Richard Ndassa
8. Pendo Richard Ndassa
9. Robert Richard Ndassa

He is also believed to have left the following assets:

(a) **Plots of land**

- 17 acres farm at Bagamoyo.
- 5 acres farm at Dodoma.
- 100 acres farm at Mvomero, Morogoro.
- 2300 square meter plot at Itega at Dodoma.

(b) **Houses**

- a house at Manzese in Dar es Salaam.
- A house at Kiseke in Mwanza.

(c) **Vehicles**

- Toyota land cruiser 200 series V8.
- Tractor.

- (f) One firearm

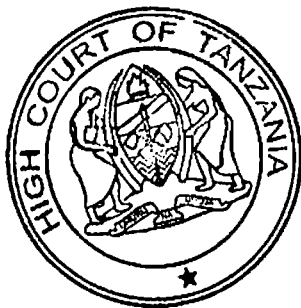
The death certificate, the minutes of the clan (wider family), affidavit of domicile, survivors' consent, the administrators' oaths, Administration Bond with surety and certificates as to the sureties' financial position were also attached to the petition.

A general citation was issued and published in the Government Gazette of 04/09/2020 and Nipashe Newspaper of 05/09/2020 and no caveat was lodged to oppose the petition. Mr. Andrew Dick Manumbu who represented the petitioners is requesting the court to grant the petition in view of lack of objection.

I have considered the matter carefully. I see no reason for refusing to grant the petition in view of compliance to all the legal requirements and lack of objection. The petition is accordingly granted. Let letters of Administration be issued

to the petitioners who shall act jointly as administrators of the estate of the late Richard Mganga Ndassa. They are directed to collect the estates of the deceased, pay the debts and distribute the balance to heirs on equal basis. They shall file an Inventory and statement of accounts on or before 30/04/2021.
