**CONSENT SETTLEMENT ORDER**

That this consent settlement order shall be recorded as a decree of the Court and Proceedings relating to the above case be marked settled and that no any further claims of similar nature or of any other nature, cause of action being similar or otherwise shall be instituted or restored, either directly or indirectly by either part in respect thereof upon the execution of this consent settlement order.
4. That the Plaintiff shall abandon all other claims as included in the plaint against the Defendant.
5. That each party to bear his/its own cost in respect of the suit.
6. That this Agreement shall constitute the Judgment and Decree of the Court and the suit shall be marked as settled and the Parties having read and understood the contents of this agreement have agreed to be bound by the terms, spirit and intendment thereof, and the Court should record it as such.
