## **JUDGEMENT**

### DEED OF SETTLEMENT OF A SUIT

(Made under section 95 read together with Order XXIII Rule 3 of the Civil Procedure Code Cap 33 R.E.2002)

# NGWEMBE, J.

The third plaintiff Mr. Bruce Christian Zenga was not among the plaintiffs who agreed with the defendants to settle their claims amicably. Thus, the other plaintiffs amicably settled their claims against the defendants by



registering a Deed of Settlement, which resulted into this court's judgement dated 5<sup>th</sup> November, 2020.

The background of the plaintiff's claim as appears in the Plaint was for payment of TZS 7, 150,000/= specific damages; TZS 20 million as general damages; and interest accrued therein with costs. However, when this case came for mediation on 5<sup>th</sup> February, 2021 the parties were successfully mediated and unanimously agreed to enter into a Deed of Settlement. The said Deed of Settlement which was executed and signed by both parties was registered in this court on 10<sup>th</sup> February, 2021.

The registered Deed of Settlement is hereby adopted as part of this judgement of this court. The terms and conditions comprised in the Deed of Settlement are as follows:-

- The 3<sup>rd</sup> Defendant has agreed to pay the 3<sup>rd</sup> Plaintiff a total sum of Tanzanian Shillings Ten Million only (Tshs. 10,000,000/=) the amount whereof is accepted by the 3<sup>rd</sup> Plaintiff as a full and final satisfaction of the whole claim;
- 2. The 3<sup>rd</sup> Defendant shall deposit the settled sum to the account of the 3<sup>rd</sup> Plaintiff within 2 weeks of filing the Deed of Settlement in Court. Payment shall be done in the following bank details:-

Bank name: Tanzania Postal Bank,

Bank Account name: Bruce C. Zenda,

Bank Account: 007 - 00099686.

3. The settlement amount shall be paid in one and equal instalment;

- 4. Upon full and final settlement of the amount, the 3<sup>rd</sup> Plaintiff shall discharge all liabilities against the Defendants herein and shall have no any further claim whatsoever as against the Defendants arising out of the said motor vehicle accident;
- 5. That parties agree that, this agreement constitutes a final agreement between them and supersedes all previous negotiations except on the terms expressly agreed herein and upon the same being filed in court it shall immediately become a decree of the Court having full force and effect as any other decree of the Court;
- 6. Each party shall bear its own costs of the suit.

Now, it is hereby declared that, the Executed Deed of Settlement effective from the date filed in this Court on 10<sup>th</sup> February, 2021, bind both parties to this suit and to the subsequent applications or suits arising from the same motor vehicle accident. Therefore, this Court doeth hereby, invoke section 95 and Order XXIII Rule 3 of the Civil Procedure Code Cap 33 R.E. 2019, to mark Civil Case No. 09 of 2020 amicably settled. Further proceed to adopt the Terms and Conditions enshrined in the Executed Deed of Settlement and quoted verbatim hereinabove, holistically, adopted forming part of this Court Decree.

# I accordingly Order.
