CONSENT SETTLEMENT ORDER

The parties having consented to settle this case through mediation, now agree as follows:

- 1. That the 3^{rd} Defendant has paid Tanzanian Shillings three million (Tzs 3,000,000/=) to the 1^{st} Defendant.
- 2. That the 3rd Defendant does herein acknowledge being indebted to the 1st Defendant to the tune of Tanzanian Shillings Seventy Two million (Tzs 72,000,000/=).
- 3. That the 3^{rd} Defendant shall pay Tanzanian Shillings Twenty Seven million (Tzs 27,000,000/=) to the 1^{st} defendant on or by 9^{th} June, 2021.
- 4. That the 3rd Defendant shall pay Tanzanian Shillings forty five million (Tzs 45,000,000/=) to the 1st defendant within the period of seven (7) months, commencing 9th June 2021 to 9th January 2022.
- 5. That the said amount shall be paid at the respective account maintained by the 3rd Defendant held at the 1st Defendant.
- 6. That in the event the 3rd Defendant defaults to pay the amount agreed as stated in paragraphs 3 and 4 herein above, the mortgaged property in the name of **LUCY** WILLIAM (the late) located on Plot No. 09 Block "32A" at Kinondoni area within

Dar es Salaam, shall be disposed of and the 1st Defendant shall only take the unpaid debt by the 3rd defendant, however such sale shall be made upon an order of this court on execution bearing in mind that there are 5 heirs of this property as seen in annexure LW1 of the plaint which is **FORM 1** issued by Magomeni Primary Court in Mirathi Namba 433/2009 and it forms part of this Consent Settlement Order.

- 7. That the 1st Defendant, 3rd Defendant and the Plaintiff shall not remove, sell, alienate, dispose, assign, transfer or create any charge on or any part of mortgaged property with **Title No. 49393**, **Plot No. 09** Block "32A" located at Kinondoni in the name of **LUCY WILLIAM**, until the 9th January 2022.
- 8. That the 3rd Defendant having paid his debt in full, the 1st Defendant shall, within fourteen (14) days release and hand over the Certificate of Title No. 49393, Plot No. 09 Block "32A" located at Kinondoni in the name of LUCY WILLIAM, to the 3rd Defendant in the presence of the Plaintiff.
- 9. That the Plaintiff shall fully relinquish and abandon all the claims stated in the plaint against the 1st, 2nd and 3rd Defendants.
- 10. That the parties shall strictly abide to the terms and conditions of this Consent Settlement Order.
- 11. That each party shall bear its own costs.
