## CONSENT SETTLEMENT ORDER

The plaintiff and 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> defendants having consented to settle this suit through mediation agree as follows:

- 1. The 1<sup>st</sup> defendant being guarantor of the 2<sup>nd</sup> defendant, shall pay the total sum of Tshs. 59,752,440.30 (Say Tanzania Shillings Fifty Nine Million Seven Hundred and Fifty Two Thousands Four Hundred Forty and Thirty Cents), being outstanding loan balance after the 3<sup>rd</sup> defendant has forfeited the sum of Tshs 6,500,085.94 (Say Tanzania Shillings Six Million Five Hundred Thousand and Eighty Five and Ninety Four Cents), being late fees.
- 2. The 1<sup>st</sup> defendant shall deposit monthly installment of Tshs. 200,000.00 (Say Tanzania Shillings Two Hundred Thousand) each month until full payment of the outstanding loan balance. The said installments are meant to clear the outstanding loan balance relating

to loan account number LSE-601001068 and shall be deposited into the 3<sup>rd</sup> defendant account with the following particulars;

- 3. The 1<sup>st</sup> defendant shall further deposit annual installment of Tshs. 10,000,000.00 (Say Tanzania Shillings Ten Million) between 1<sup>st</sup> April to 1<sup>st</sup> July each year effective from 28<sup>th</sup> September 2021 up to 28<sup>th</sup> May 2026, until full payment of the outstanding loan balance. The annual installment herein shall be paid through the 3<sup>rd</sup> defendant's bank account whose particulars are shown under paragraph 2 above.
- 4. The 3<sup>rd</sup> defendant shall extend and reschedule the payment schedule for the 1<sup>st</sup> defendant and restructure the loan to be repaid by the 1<sup>st</sup> defendant under the new terms.
- 5. Following the restructuring of the loan by the 3<sup>rd</sup> defendant, the 1<sup>st</sup> defendant shall pay Tshs. 59,752,440.30 (Say Tanzania Shillings Fifty Nine Million Seven Hundred and Fifty Two Thousands Four Hundred Forty and Thirty Cents only being the outstanding loan amount.
- 6. The 1<sup>st</sup> defendant shall deposit the loan amount mentioned under paragraph 2 above on the 28<sup>th</sup> day of each month until full payment of the loan.
- 7. Upon full payment of the outstanding loan amount, the 3<sup>rd</sup> defendant shall handover to the 1<sup>st</sup> defendant the mortgaged property, with title

Municipality.

8. All loan agreements, loan guarantee agreements and their annexures

signed by the 1st and 2nd defendants on 18th October, 2016 shall be

read together with this Consent Settlement Order.

9. In the event of a default by the 1<sup>st</sup> defendant in effecting monthly

instalments, the 3<sup>rd</sup> defendant shall be entitled to execute this

Consent Settlement Order including the right to sell the mortgaged

property that secured the outstanding balance of the restructured

loan agreement without giving further notice.

10. The terms of this Consent Settlement Order shall be recorded as

decree of this Court and be enforceable as such.

11. The plaintiff shall abandon all other claims against the defendants as

included in the plaint.

12. Each party to bear own costs.
