In this ruling, the applicant applies to this Court under section 14 of the Probate and Administration of the Estates Act [Cap 352 R.E 2019] and Rule 14 (1) (2) and (3) of the Probate Rule GN. 369 of 1963 for the following orders;

- i) That this Honourable Court be pleased to issue an order directing or issue direction to the appointed receiver to refrain discharging or executing its obligations and duties as Administratrix of the estate of the late Abdulrahman Obed Noel pending the determination of Probate Appeal No. 07 of 2021.
- ii) Costs of this application be provided for and
- iii) Any other orders as the Court may deem fit to grant.

The reasons for this application as mainly made clear in the affidavit filed in support of the application are that there is an appeal filed before this court against the decision which appointed the respondent as a receiver, which is Probate Cause No. 01 of 2021 of Geita District Court.


This application has not been objected by the respondent, on the sole ground that since there is an appeal before this court, a focus be directed to the appeal for the same to be heard on merit.

That being the state of affairs, and having considered the prayers in the chamber summons and the reasons for the application as elucidated in the affidavit filed in support of the application, I find merit in the application and grant it save the prayers for costs.

That said, the appointed receiver is hereby directed to refrain from discharging her obligation or duties as Administratrix of the Estate of the late Abdulrahman Obed Noel pending hearing and determination of Probate Appeal No. 07 of 2021.
