- 2) **Imran Haroon - (Son);**
- 3) **Zakaria Haroon - (Son);**
- 4) **Zeenat Haroon - (Daughter);**
- 5) **Abid Haroon - (Son); and**
- 6) **Zameer Haroon - (Son).**

Whom collectively through their Family Meeting that was held on 10th May 2021, consented that the Petitioner herein be appointed the Administrator of the estate of the Late **HAROON DAWOOD ABDALLAH**.

The general Citation was issued and published in the **Government Gazette** of **25/06/2021** and the Nipashe Newspaper dated **29/06/2021** at page 18. To date, no caveat has been lodged to oppose the proposed appointment.


In the event therefore, **Mr. Claudio Msando**, a learner Advocate who represented the Petitioner is praying for the grant of the Petition in view of the lack of objection.

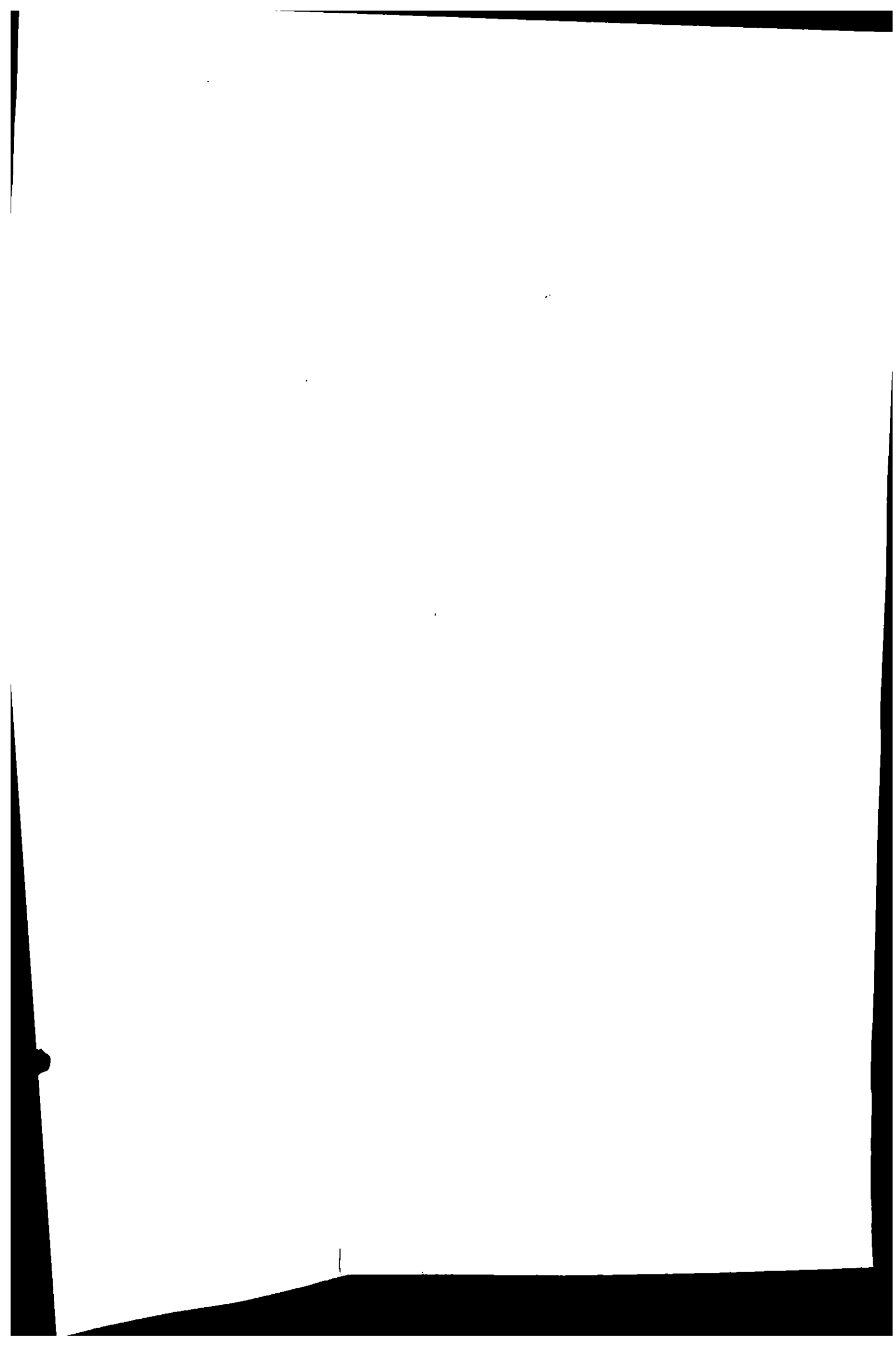



It is so ordered.


