RULING

The four Applicants namely:

- 1. PF. 1934 Inspector Erasto Mtweve
- 2. PF. 22590 A/ Inspector Mahuna Salehe Koshuma
- 3. WP. 3996 SGT Halima Hemedi Malidadi and
- 4. PF. 21432 A/ Inspector, Lameck Nyamya are charged in the Resident Magistrate Court of Dar es Salaam with four counts (one under the Penal Code) and three under the Economic and Organized Crime Control [Cap 200 RE 2019]. As the offences under the Economic and Organized Crimes control Act are bailable in this court only, they have

applied for bail in this court. The Respondent/ Republic do not object the grant of bail. Ms Florida Wenscelaus has requested the court to take into consideration the requirements of section 36(5) and (6) of the Economic and organized Crime Control Act while considering bail condition.

In these proceedings the Applicants are represented by Mr. Mashuhu Saba Saba, Mr. Amin Mohamed Mshana, Mr. Daniel Bushele and Mr. Shuma Kisenge, all learned advocates

I have carefully gone through the Applicant's application, the affidavit in support of the application as affirmed by Mr. Amin Mohamed Mshana, learned advocate and the submissions made the learned State Attorney and I grant bare to the accused upon fulfilling the following conditions;

- Each accused person shall sign a bail bond of Tshs
 212, 440,000/=(not cash)
- ii. Save the 4th each accused person must secure two reliable sureties who are ready and willing to sign a bail bond of Tshs 106,220,000/= not cash.
- iii. Same for the accused or any of his surety must deposit to the court cash or other property worth Tshs 53,110,000/=. While the property to be deposited is immovable the accused or his surety shall deposit to the court a title deed or any evidence showing that he/she possess a properly worth that amount.

iv. For purpose of approval each securely shall produce to the Deputy Registrar of this court his National Identity Card (ID) for inspection or an introduction letter from his Kitongoji Executive Officer or Chairman or a recognize and reputable employer.

All sureties shall be approved by the Deputy Registrar of this court and the records of these proceedings shall immediately be certified and a copy thereof transmitted to trial court for record purposes.

The accused person shall attend their case at the trial court as shall. The 4th accused shall be released on bail on executing a bail bond of Tshs 5.8m with one surety in the like sum not case.
