## **RULING**

19th & 22nd July, 2022

### ITEMBA, J

The late PAULIN REMIGIUS KAGARUKI died on 10<sup>th</sup> day of December, 2020. He left a will mentioning CONSOLATA PAULIN MUKALUGAMBWA and GILBERT PAULIN KAGARUKI as executors of the will. The two have now filed a petition before this court to be appointed as executors. On 25<sup>th</sup> June, 2022 the petition was published on Uhuru newspaper. No caveat was filed in opposition of the petition therefore the petition was set for hearing on 19<sup>th</sup> July, 2022.

The second petitioner Mr. Gilbert Paulin Kagaruki was the sole witness who testified as PW1. He stated that the deceased was his biological father who died on 10<sup>th</sup> December, 2022 at Bugando Hospital in Mwanza. That the deceased was buried in Igombe, Kashozi within Kagera region on 13<sup>th</sup> December, 2022. PW1 added that the family was informed by the deceased's grandson that the deceased has left a will. A clan meeting was held and being guided by the deceased's will, the 1<sup>st</sup> and 2<sup>nd</sup> petitioners were proposed to be the executors of the deceased's will. It was also Pw1's evidence that the 1<sup>st</sup> petitioner, his sister, could not appear before the court as she is working in Sumbawanga. PW1 also produced the death certificate of Paulin Remigius Kagaruki, the said minutes of the clan meeting and the Will. These documents were admitted as exhibit P1, P2 and P3 respectively.

I have considered the petition, evidence of the petitioner and the supporting documents thereof, and, as mentioned earlier on the petition is unopposed.

I therefore grant the petition and appoint both petitioners as executors of the deceased's will.
