RULING

MRUMA,J.

Following a complaint letter addressed to the Judge incharge dated 27.6.2022 which is to the effect that during consideration of bail conditions this court did not distribute equally and according to the law

the value of the trophy stated in the charge sheet so as to enable each accused to share it in consideration of their bail, I called for records for purposes of satisfying myself whether the complaints were correct. I also gave parties opportunity to address me on the complaint.

When the accused were given and audience to address me they told the court that they were unable to fulfil bail conditions because they have failed to obtain sureties with original documents exhibiting their possession of immovable property worth the value of the bond required.

Having considered their complaints this court is of the view that the bail conditions it set were reasonable and appropriate in the circumstances of the case. The only clarification that need to be given is that the conditions to produce evidence of possession of immovable property did not require sureties to exhibit or produce original document of ownership. What the court ordered is for the intended surety or the accused himself produce evidence that he owns such immovable property.
