RULING

Masara, J;

This Court granted Probate to RESHMA JAIDEV SON on 5th May, 2021. The executrix was granted 6 months within which to prepare and file an Inventory and 12 months to file final Accounts of the estate. In a very short time, the Executrix through her lawyers, Mawalla Advocates, submitted both the Inventory and Accounts. That was on 30th June, 2021 hardly two months from the date of granting the Probate. After receiving the documents above mentioned, this Court marked the Probate officially closed on 30th July 2021. By so doing, the Executrix was discharged from her duties in the Estate. Thus, the letters filed on behalf of Reshma Jardev Soni on 14/01/2022 and 15th March, 2022 seeking adding some properties in the Inventory regarding the Probate were filed after the Probate had already been marked closed. Amendment of the Inventory should have been made before filing of the Final Accounts or, at the latest, before the



Probate was marked closed. Consequently, this Court cannot grant the request as presented.

It is so ordered.
