RULING

Before me is an Application whereby the Administrators to the estate of the **Late Mercy Anna Mengi**, being **Ms. Regina Mengi** and **Mr. Abdiel Mengi** respectively, are praying for an order of this court for enlargement of time to file a complete Inventory and full estimates of accounts of the Estate of the **Late Mercy Mengi (Deceased)**.

Submitting for the Application, the Applicants' counsel **Mr. Grayson Laizer** had two major grounds to support the Application.

1st that, prior to this Application, there was a pending **Probate Cause No. 39/2019** of which involved the deceased's ex-husband's estate as to declare the deceased's share; the outcome which was yet to be established.

2nd that there was also before the court **Matrimonial Cause No. 8/2015** between the Deceased herein her ex-husband the late and **Mr. Abraham Mengi** where the same was still undermined to establish both parties rights.

The counsel informed the court that, as of now, both above mentioned matters have been determined; hence the instant Application.

Further to that, the Administrators herein will also need time to issue Creditors Notice of which needs 60 days before the Probate in issue is closed.

It is from the above, **Mr. Laizer** prayed this court to grant the prayer sought.

I have carefully listened to the reasons advanced for the prayer sought. I am satisfied that the reasons behind the prayer

are tangible and reasonable to command this court to grant the prayer sought.

In the event therefore, **I proceed to grant the Applicants with Extension of SIX MONTHS' time from the day of this Ruling in that respect.**

For avoidance of doubt, this court is granting the Applicants i.e, the Administrators to the estate of the **Late Mercy Anna Mengi** six months' time to finalize the preparation of inventory and estimates of accounts so as to file the complete Inventory and full estimates of accounts in that respect before this Honourable Court.

It is so ordered.
