The late Patricia Fortunata Mwanukuzi died leaving a will and Probate in respect of that will was granted to Margaret Malwa Bandora and Christine Mwanukuzi Kwayu vide probate and administration cause No 91 of 2020.

The will, unfortunately, did not include other properties of the deceased, namely:

- i. A residential House located on plot No. 7, Block 23A, Mwananyamala, Kinondoni.
- ii. Two residential houses, located on plot No. 164, Ufipa Street, Kinondoni.
- iii. A car registration No. T. 615 DHJ, Toyota Land Cruiser, station Wagon and a truck No. T.639 CCT, and

- iv. Bank account No.7069987002 at Diamond Trust bank, Morocco Branch, Dar es Salaam.

As these properties now fall under intestacy, the petitioner has petitioned for letter of administration in respect of those properties. The deceased left surviving her:

- i. Margaret Malwa Bandora (daughter).
- ii. Victoria Nyanzobe Mwanukuzi (daughter).
- iii. Christine Mwanukuzi Kwayu (daughter).
- iv. Jonathan Mwinamila Michael Mwanukuzi (son).
- v. Joseph Nkwabi Mwanukuzi (son).
- vi. Dr Andrew Mpema Mwanukuzi (son) and
- vii. Basilla Kulubha Mwanukuzi (daughter).

The petition was published in the Government Gazette of 08/04/2022, the Guardian newspaper of 06/04/2022 and Nipashe newspaper of 06/04/2022. In terms of section 76 of the Probate Rules, fourteen days from the last publication has expired. Since there is no objection, the petition is non-contentious and for that matter I grant it. Margaret Malwa Bandora is hereby granted letters of administration to administer all the estate of the late Patricia Fortunata Mwanukuzi which falls under intestacy.
