2. **Highlands Home and Office Services Limited** (herein called the Company), was incorporated on the 4<sup>th</sup> November, 2008 under the Companies Act, Act No. 12 of 2002 with certificate of Incorporation No. 68276.

4. That there is a complete breakdown in relations between the directors, as directors all of them cannot take authority in the business and affairs of the company and thus the directors and shareholders they have come to conclusive remark that it's just and equitable that the Company should be wound up;

- (b) That the Company is unable to pay its debts:
- (i) That as far as the Petitioners are aware, the Company has insufficient assets to apply to settle creditors' claims arising from various company conducts, Morcover, Petitioners believes that there might be more claims that they do not have knowledge about, as they do not have immediate means of verifying every such claims;
  - (ii) That the Petitioners are aware of the fact and issue that the company is unable to pay its debts and liabilities as the fall due;
  - (iii) That the Petitioners are aware of the fact and issue that the value of the company assets is less than the amount of its liabilities taking into account the contingent and prospective liabilities of the company.
  - (iv) That the Petitioners have reasonable cause to believe that the Company will be unable to discharge its indebtedness if execution of judgements, decree or orders of any court in favour of any creditor of the Company is initiated.
7. In the circumstances, it is just and equitable that the company should be wound up.

The Petitioners Therefore Prays as follows:

- (a) That Highlands Home and Office Services Limited may be wound up by the Court under the provisions of the Companies Act.
