As a fully searchable offline version of the TanzLII service, which publishes case law from all superior courts in Tanzania, Pocket Law ensures that updates are synchronized with TanzLII, maintaining familiarity and ease of use. This initiative aligns with the Tanzanian justice sector's commitment to accessible law, as demonstrated during Law Week 2024.
